

Propomel drops for children



Propolis drops

10% propolis extract
in propylene glycol
Number of drops/ml: 38

Action:

Propomel drops for children contains propolis extract which acts as a “natural antibiotic” in the treatment of upper respiratory tract infections, flu, common cold and conditions accompanied by increased body temperature and exhaustion. Propolis works favourably on strengthening the immune system's defence. It relieves symptoms of the diseases of the gums, oral mucosa, throat and pharynx. It helps with gastritis and colitis, as well as with anaemia.

The preparation is intended for children and adults intolerant to alcoholic (ethanol) propolis solution. Product does not contains alcohol.

It is recommended preventively or in conditions of exhaustion and infection. Can be used external for small skin damage.

Method of use:

For internal use:

3 times a day 10-15 drops should be poured on a sugar cube or a spoonful of honey and eaten.

For oral rinsing:

3-4 times a day dissolve 10-20 drops in half a glass of water and rinse your mouth.

For a throat rinsing:

3-4 times a day pour 10-15 drops on a sugar cube and let it slowly dissolve in your mouth.

For external use:

2-3 times daily apply the drops directly to the skin.

Notes:

Food supplements are not a substitute for a normal and varied diet. The recommended daily intake must not be exceeded. Keep it out of reach of children.

Warnings:

Persons allergic to honey and bee, or in case of hypersensitivity to any component of the product should not use the preparation. The product is not recommended for pregnant and breast feeding woman, children under the age of 6.

Method of storage:

Keep it in original packaging, at a temperature up to 25°C, in dry and dark place.

Shelf life: 2 years

Packaging: Bottle with 30 ml of the product.
