Effects:

Timal product unifies herbal extracts which facilitate expectoration and help regenerate damaged airway mucosa.

Thyme stimulates the secretory activity of airway epithelial cell cilia, facilitates expectoration of accumulated mucus and exhibits antimicrobial activity. Primrose is a medicinal herb which due to its composition, has the ability to break up thick bronchial mucus, accelerates the excretion of mucus from

the bronchi and facilitates breathing and expectoration. Primrose extract also has an antiseptic effect and can reduce inflammations of the oral and pharyngeal mucosa.

Basil is a medicinal herb which, due to its aromatic eugenol oil, is traditionally used for alleviating airway mucosa inflammations.

Rose hip is a rich and essential source of vitamin C, which is indispensable for the body's immune system.

Dosage and instructions for use:

Adults: 3 times a day 1 tablespoon (15 ml). Children over 12 years of age: 3 times a day 1 teaspoon (5 ml).

Shake before use.
